2. RESERVATION OF SEATS: -

The details of the seat plan along with reservation for the above-mentioned colleges **will be declared at the time of counselling.**

3. ELIGIBILITY FOR ADMISSION INTO FIRST SEMESTER OF 4 YEARS B.TECH. PROGRAMME

To be eligible for Admission to any of the Colleges a candidate must fulfil the following conditions: -

- (a) The applicant must be an Indian Citizen.
- (b) **The applicant must be a Permanent resident of Assam** [with a valid PRC of Assam issued by the competent authority].
 - i. Applicants who are not PRC holders of Assam and wish to be considered for the Central Government Employee (CGE) Quota must submit proof of their permanent residency from the concerned state authorities outside of Assam. (Permanent residents of Assam are not eligible to be considered under CGE quota).**

Note: Son/Daughter of employees of Central Government and Central Government Public Sector Undertaking (CGE) who are posted in Assam for less than 20(twenty) years and not Permanent Residents of Assam are eligible to apply under CGE quota

- (c) Candidate must pass the Qualifying Examination (10+2 standard) in single sitting, without any grace marks in the relevant subjects/ courses at 10+2 level and also must pass individually both in Theory and in Practical.
- (d) Candidate must secure a minimum of **45% (40 % in case of candidates belongs to reserved category in the subjects taken together) in the Qualifying Examination (10+2 standard) as per AICTE Approval Process Hand Book -2024-2027.**

OR

Candidates who have passed 3-years Diploma in Engineering & Technology under the State Council for Technical Education, Assam, with 45% (40% for reserved category) marks in the Final Diploma Examination. [All other eligibility criteria will be same as per guideline]

Note: i) Reserved category includes OBC/MOBC/SC/ST(P)/ ST(H).

ii) Under OBC/MOBC, candidate must submit valid Non Creamy Layer (NCL) certificate issued by the competent authority of Assam.

iii) In case of Person with disabilities required percentage is as per his/her original category.

- (e) **The minimum age of a candidate must be 17 years as on 31st December 2026 .The Candidate must not be below 17 years .**
- (f) **There is no UPPER age limit.**
- (g) The Candidate must possess a good moral character. (Certificate from the Head of Institute last attended to be submitted).
- (h) The Candidate must be physically and mentally fit. (Medical Certificate from the Medical Officer/Medical Practitioner to be submitted as and when required).

Note: Depending upon the subjects they have studied in the 10+2 standard, they will get the branches for choice filling. Subject combination wise eligible branches are mentioned in **TABLE-1.**

4. ADMISSION PROCEDURE.

- a) Candidates will be selected for counselling and Admission on the basis of the rank of CEE – 2026 conducted by ASTU. The Schedule and guidelines of counselling will be published by the Directorate of Technical Education, Assam in due course of time.
- b) Accordingly, based on the availability of seats, rank and caste/category-wise online counselling and allotments of seats will be made.
- c) Students are requested to visit DTE, Assam website (<https://dte.assam.gov.in>) for the latest updates) as well as the ASTU website.

5. REQUIRED MANDATORY DOCUMENTS FOR ADMISSION INTO B.TECH. COURSES FOR ALL CANDIDATES ARE AS FOLLOWS: -

6. Candidates must apply online against NCC quota at the time of online counselling.

For considering the merit for admission in NCC Category, the following criteria will be considered:

-

I)	"C" certificate with Grading "A" would be treated as Rank- I
II)	"C" certificate with Grading "B" would be treated as Rank- II
III)	"C" certificate with Grading "C" would be treated as Rank- III
IV)	"B" certificate with Grading "A" would be treated as Rank- IV
V)	"B" certificate with Grading "B" would be treated as Rank- V
VI)	"B" certificate with Grading "C" would be treated as Rank- VI
VII)	"A" certificate with Grading "A" would be treated as Rank- VII
VIII)	"A" certificate with Grading "B" would be treated as Rank- VIII
IX)	"A" certificate with Grading "C" would be treated as Rank- IX

In case of tie in the rank of NCC certificate, then the merit of the applicants against NCC quota will be decided by the rank in CEE 2026.

Required Mandatory Documents :- The candidates applying against NCC quota have to show the Original Copy and submit the photocopy of the N.C.C. Examination Certificate from the Issuing Authority in the rank, not below the Deputy Director General National Cadets Cops, Ministry of Defence, Govt. of India. **Certificates of merit (NCC Certificate) issued by the Head of the Institution / College/School will not be accepted.** During the counselling for Admission, a candidate has to submit the original certificate from the issuing authority i.e. Issuing Authority in the rank of not below the Deputy Director General National Cadets Cops, Ministry of Defence Govt. of India.

7. Candidates must apply online against Sports quota at the time of online counselling.

Note - The applicant against Sports quota seats must represent his/her State/Country in National Games / Asian Games or Olympic Games. The merit will be decided in order of Medals won/ participation in the following order of Preference: (Subject to modification)

- i. Medal winner of Olympic Games/ World Championships

- ii. Participants in Olympic Games/ World Championships
- iii. Medal winner of Commonwealth Games/ Asian Games/ Asian Championships
- iv. Participants in Commonwealth Games/ Asian Games/ Asian Championship
- v. Medal winner of SAF Games/ National Games/ National Championships (Olympic recognized disciplines)/ National Cricket Tournaments organized by BCCI
- vi. Participants in SAF Games/ National Games/ National Championships (Olympic recognized disciplines)/ Nation Cricket Tournaments organized by BCCI
- vii. Medal winner of National School Games organized by School Games Federation of India/ All India Rural Sports/ Women Sports Festival/ North East Games/ National Inter School tournament organized by SAI NSNIS, Patiala under the Ministry of Youth Affairs and Sports, Govt. of India
- viii. Medal winner of State Games/ State Championships/ Tournament organized by Assam Olympic Association/ State Sports Association / Directorate of Sports & Youth Welfare, Assam.
- ix. In respect of seats against Sports Quota, if there is tie, i.e. prizes are equal (Gold/ Silver/ Bronze/ or preferences as above) or no prizes is obtained by any candidate then merit will be decided by taking the rank in CEE-2026.

NB: -(A) In addition to the above mentioned criteria the candidates must receive a medal at least at State level event organized by duly recognized body during preceding three years of appearing in the Entrance Examination for admission into Engineering Colleges.

(B) Required Mandatory Documents: Certificate issued by the Director of Sports and Youth Welfare, Assam.

SPECIAL NOTE: -

The above mentioned criteria may be changed subject to the order of the Directorate of Sports & Youth Welfare Department of Government of Assam.

The selection of candidates will be made and finalized by a committee comprising of the following members: -

8. ADMISSION PROCESS

Counselling Fee

All candidates will have to pay Rs.800/- [Rupees eight hundred] only [Non –refundable] as Counselling Fee at the time of Counselling.
